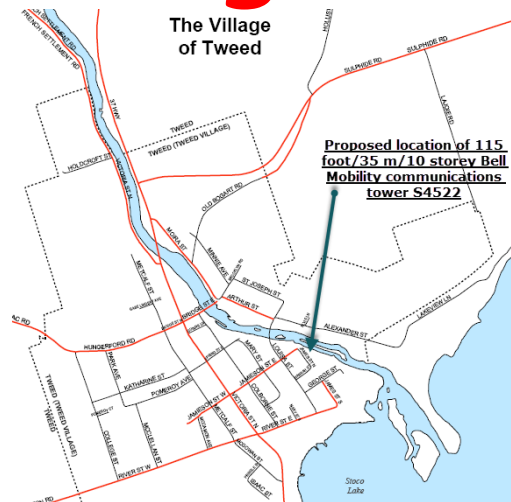


Public Meeting

Bell Mobility's Proposed Cell Tower - Stoco Lake W4522 Village of Tweed

Thurs. March 27, 2014, 6-8 p.m. - 'White Building' (beside arena, St. Joseph/Louisa Street, Tweed)



A 35 m/10-story cell tower is proposed in an area surrounded by homes and recreational uses on the Moira River in the village. Finally, concerned citizens can speak directly with Bell about how the site was selected, alternative locations, and potential effects. *Our goal is to have the proposed tower relocated to an area that does not adversely affect so many households and the village in general.*

- Location of proposed tower in a residential / recreational area of the village
- Immediate, and long-term cumulative, effects on health - especially children
- Potential effects on environment (e.g., bees & birds)
- Considering the use of existing towers
- Declining property values
- Visual impact for neighbours & the village
- Future expansion of this tower with additional antennae/increased height
- Site selection and consultation process
